More than half of abortions today are through taking abortion-inducing drugs. Two pills, mifepristone (Mifeprex) and misoprostol (Cytotec), are prescribed by a healthcare provider and are then taken by a woman to end a pregnancy.

The Federal Drug Administration (FDA) now allows for the distribution of these pills through online telehealth sales, allowing for no-test, online distribution of the pills to any person, minors, men, or pregnant women. In May 2025, a study of more than 800,000 health insurance claims of women who received abortion-inducing drugs reported substantially higher rates of medical complications than had been reported in earlier clinical trials, raising questions among some policymakers and medical professionals about the safety of no-test, mail-order distribution models.

Ultrasound screenings (a simple imaging technique used to show images of structures within the body) are often used to determine how far along a woman is in pregnancy. They are also used to determine if a woman has an *ectopic pregnancy*, a condition occurring in 1-2% of pregnancies where the fetus has implanted outside of the uterus/womb. In an ectopic pregnancy, the abortion-inducing drugs will not end the pregnancy, and the woman can have severe complications, including death. A blood test is needed to check a woman's Rh blood status. About 15% of women have Rh-negative blood. If the blood of an Rh-positive fetus gets into the bloodstream of an Rh-negative woman, the woman's body produces antibodies that could attack the fetus' blood cells, leading to serious health problems, even death, for a fetus or a newborn. The antibodies also put the mother's future children at risk while in the womb. Antibodies can be formed after a miscarriage, ectopic pregnancy, or an abortion. If Rh-negative blood is detected very early in the pregnancy, a prescription medicine (Rhogram) can be given to prevent antibodies from forming. There is evidence that some women have been given abortion pills without their knowledge and consent, generally by partners acting against their wishes. Some argue that this practice is more easily done with online sales of the abortion pills. The Washington Post, CNN, and other news sources have reported such cases. In several instances, men have been charged and found guilty of secretly administering abortion-inducing drugs to women without consent. **

Women taking the abortion pills are instructed to flush the products of the abortion (placenta, the human embryo or fetus, blood) in the toilet. This medical waste can be “hazardous if not disposed properly.” Additionally, given how one of the abortion pills (misoprostol) is administered/inserted, some of that medication could be passed into the toilet as well (see [this website](#)). All of this could then pass to the wastewater system, potentially affecting the fertility of animals and fish, according to the article by the FDA, *Don’t Flush! Why Your Drug Disposal Method Matters*. Abortion pills are the leading abortion method in the United States, with at least 600,000 or more of these abortions occurring per year. **

[NEW] Planned Parenthood's latest annual report indicates the organization received nearly \$700 million in government funding, representing about 34% of its total budget. In recent years, various members of Congress and public organizations have called for a federal review of Planned Parenthood's practices, citing concerns about financial management, compliance with federal funding requirements, and workplace issues. For example, the Government Accountability Office has reported that Planned Parenthood affiliates received approximately \$89 million in Paycheck Protection Program loans, which some lawmakers argue were distributed improperly. In addition, several employee lawsuits have raised workplace-related allegations, and some complaints have focused on reporting practices (such as a failure to report possible sex crimes against women) and quality-of-care disputes. These matters remain contested and under review in different legal or administrative settings.

By comparison, [Planned Parenthood reports operating about 600 health centers](#). [National workforce data](#) also show a large number of primary-care clinicians practicing in the United States, including approximately 268,000 primary care physicians, 271,000 nurse practitioners, and 26,000 physician assistants.

Planned Parenthood reports that it is one of the nation's largest providers of gender-related medical treatments, including puberty blockers and cross-sex hormones, and these services have expanded in recent years as part of its broader healthcare offerings. Some Planned Parenthood locations provide these treatments to minors, though state laws differ regarding whether parental involvement or consent is required. Medical guidelines note that these treatments may involve potential risks –including effects on bone density, fertility, and other aspects of development – and research on long-term outcomes is ongoing. Such protocols can permanently sterilize minors. Some minors later discontinue or reverse their gender transition, raising questions about reversibility. In recent years, several European health authorities have tightened their protocols for minors, and many U.S. states have enacted new regulations addressing these treatments. ^{**}
